ORDER

Whereas Ministry of Home Affairs, Government of India vide no. 40-3/2020-DM-I(A) dated 24th March 2020 issued orders for imposing lockdown in the country till 14th April 2020.

Whereas by order vide no. 40-3/2020-DM-I(A) dated 15th April the Ministry of Home Affairs has extended the lockdown till 3rd May 2020.

Whereas during the lockdown the States were directed by order No. 40-3/2020-DM-I(A) dated 29th March 2020 to ensure that migrant workers stayed where they were or kept in nearest shelter and States were required to take care of their accommodation, food etc.

Whereas Ministry of Home Affairs by its order No.40-3/2020-DM-I(A) Dated 19.04.2020 further issued direction resolving issues regarding migrant workers allowing intra-state movement of workers of that state.

Whereas Department of Disaster Management and Relief, Government of Rajasthan has issued order No. 5241-390 dated 26.04.2020 appointing nodal officers for various states to resolve the issues relating to problems of migrant workers of that state staying in Rajasthan and Rajasthani workers staying in those states, for better and effective coordination with central government and other State Governments on this issue, Undersigned being the Chairperson of State Executive Committee and CEO of the State Disaster Management Authority issues the following order for formation of a coordination committee as per the direction of SDMA.

Whereas the Committee will be headed by Sh. Subodh Agrawal, Additional Chief Secretary, Industries, Micro Small & Medium Enterprise (M.S.M.E.), State Enterprises and NRIs & Delhi Mumbai Industrial Corridor and OSD, Bhiwadi Industrial Development Authority & Additional Chief Secretary, Investment & NRIs, BIP, Rajasthan, Jaipur and following members will be part of committee.




This order shall be deemed to have come into force with immediate effect.

Annexure -1

(Protocol Norms)

- a) Transit camps are established at the border check posts with the neighboring districts.
- b) Adequate arrangement for food, drinking water, shade & basic medical facilities are provided at the cheer points and transit camps.
- c) Officials and staff of district administration (Patwari & Gram Sevak), Police, transport, Medical & Health Department are deployed in these transit camps.
- d) Large spaces, with building are acquired and earmarked for the migrant workers where they could be segregated properly, observing the social distancing norms.
- e) They must ensure that under no circumstances, a situation should arise that social distancing norms or MHA, MOHFW (GOI) or State Govt. Norms are violated.
