ORDER

Whereas Ministry of Home Affairs Government of India vide its order No. 40-3/2020-DM-I(A) dated 24th March 2020 issued orders for imposing lockdown in the country till 14th April 2020.

Whereas by order 40-3/2020-DM-I(A) dated 15th April, the Ministry of Home Affairs has extended the lockdown till 3rd May 2020.

Whereas during the lockdown the States were directed by order No. 40-3/2020-DM-I(A) dated 29th March 2020 to ensure that migrant workers stayed where they were or kept in nearest shelter and States were required to take care of their accommodation, food etc.

Whereas Ministry of Home Affairs by its order No.40-3/2020-DM-I(A) Dated 19.04.2020 further issued direction and resolving issues regarding migrant workers allowing intra-state movement of workers of that state.

Whereas the Honourable High Court of Rajasthan has also taken cognizance of position of such worker, the undersigned being the Chairperson of State Executive Committee directs the following officers to immediately leave for the districts mentioned against their name and coordinate with the district authorities to resolve their issues including intra-state movement as allowed by order dated 19.04.2020 mentioned above and planned inter-state migration also, as and when permitted, ensuring strict observance of medical and safety protocols of screening and social distancing. Detailed protocol norms are annexed herewith.
